Release & Hold Harmless Agreement

Further, the undersigned requests that BAS allows him/her to participate in BAS Activities and in consideration thereof agrees to hereby release and forever discharge BAS, its officers and directors, and its employees, agents and any parties volunteering on behalf of BAS, from all actions, claims, damages, costs, liens, expenses or lawsuits of any kind growing out of, or related to, any Activities of BAS in which the undersigned participates.

The undersigned further acknowledges that this is a full and complete release for all injuries and damages, which the undersigned may sustain as a result of the undersigned's participation in any Sports Related Activity.

Sportsmanship Contract

We want to be a different kind of athletics program, and we need your help. We desire to have a well-organized, competitive program in an environment where the highest value is people. We ask that you contribute to creating and maintaining this kind of environment by agreeing to this sportsmanship contract.
