



POLICY REGARDING WORTHY STUDENT FUNDS

1. Recipients (adult representatives and students) of worthy student funds:
 - a. Be a member(s) of the Camarillo Seventh-day Adventists Church.
 - b. Be faithful to their tithe and offerings to the Camarillo Seventh-day Adventist Church.
 - c. Attending church regularly
 - d. Submit a copy of the previous year's income tax return (upon request)
 - e. A planned family budget for the period funds are requested
 - f. Should demonstrate financial restraint and evidence of an attempt toward becoming self-supporting.
2. The Camarillo Seventh-day Adventist Church will pay aid directly to the school.
3. Fifty percent (50%) of the tuition costs will be the limit of aid given to any student unless extreme circumstances show the need for additional assistance.
4. Representatives of the Camarillo Seventh-day Adventist Church's church board (pastor (s), elder, and treasurer) will meet in April to consider requests for worthy student aid for the upcoming year. The requests, along with recommendations, will be shared with the Church Board for approval. The application for student aid must be submitted, together with supportive documents, no later than March 31st, 2026.
