Fee Schedule (K-8):

Registration Fee: \$475. ___ Due before admittance to Alpine Christian School. (10% discount for early registration **IF** no outstanding balances from previous school year and new school year forms must be completed and early registration fee **paid by NOON June 19, 2026**).

Registration fee is **per student** and is to be **paid in full** for each student before admission to ACS. Registration fee covers the cost of books, most classroom supplies, student insurance, achievement testing, and library materials.
