

- The ceiling work will likely take a couple of months; any remaining or additional expenses will be brought to the next board meeting for approval.

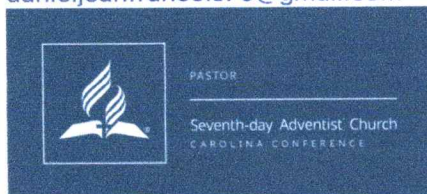
Rationale: addressing a potential safety hazard in our primary worship space, preventing further damage, and minimizing liability.

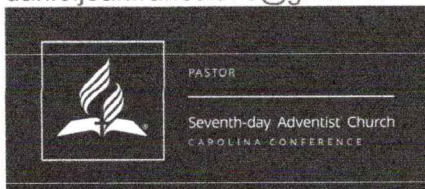
